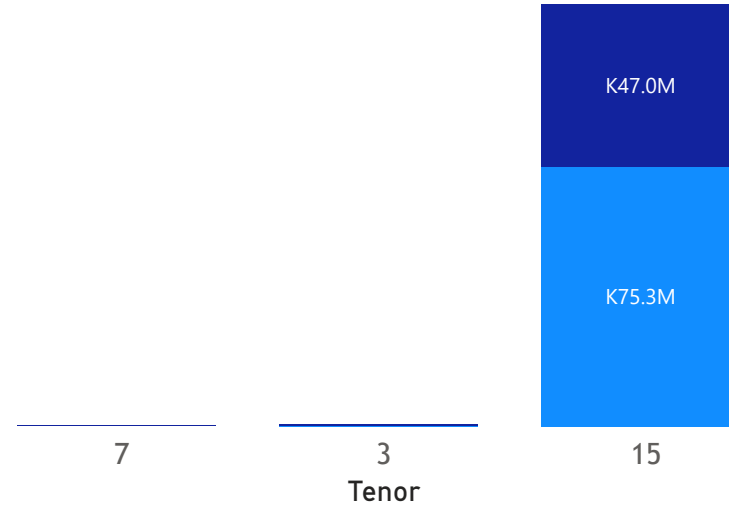

## Market Value YTD



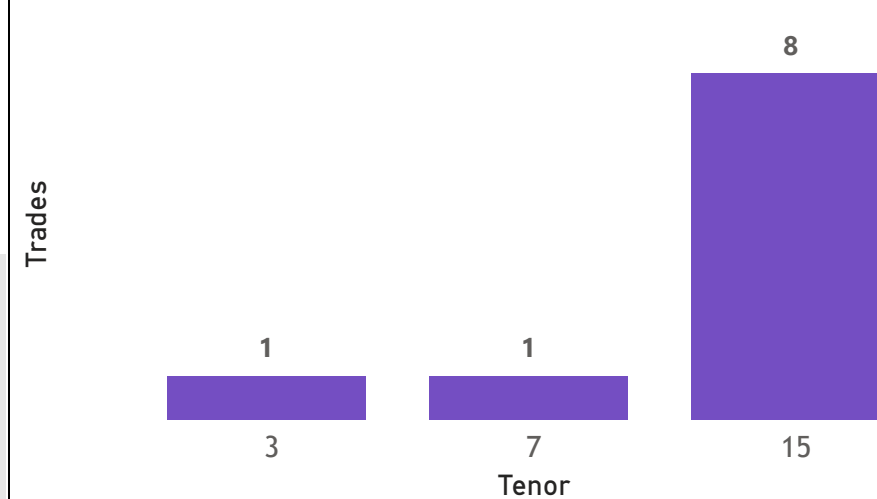
