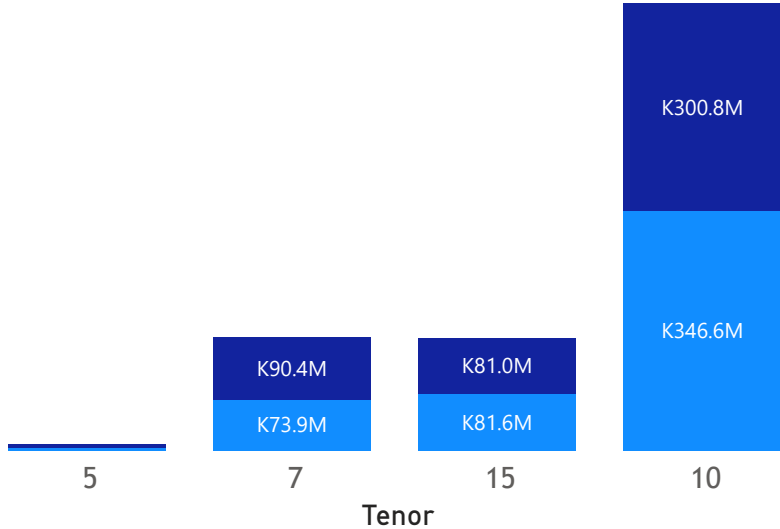

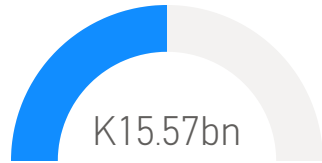

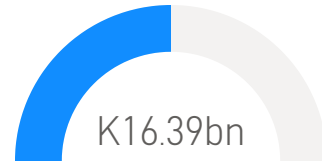

## Nominal Value YTD

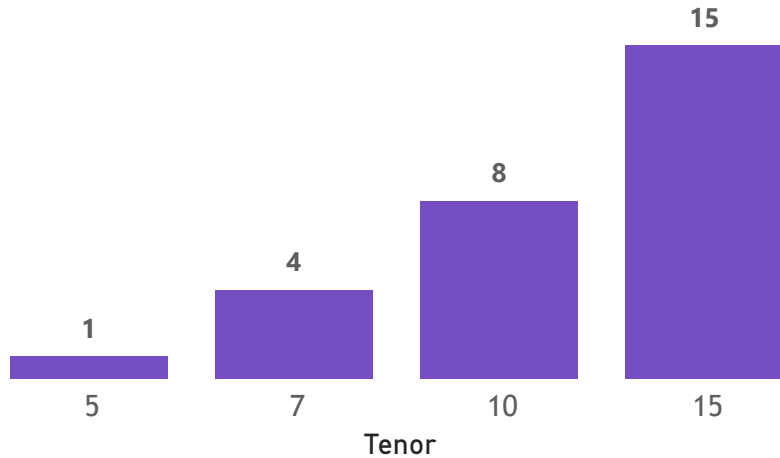
