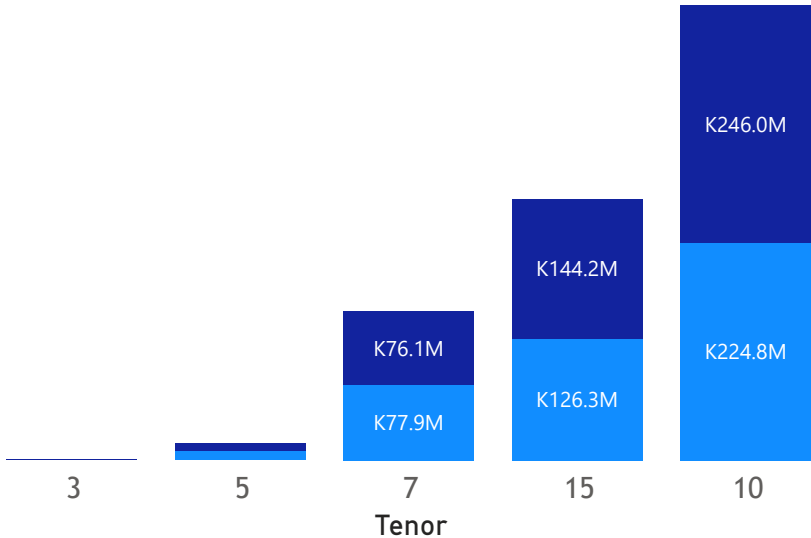

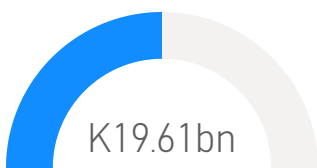

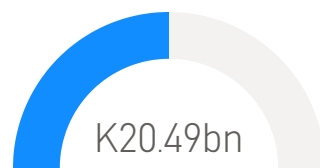

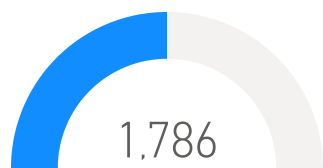
Market Value YTD



Nominal Value YTD

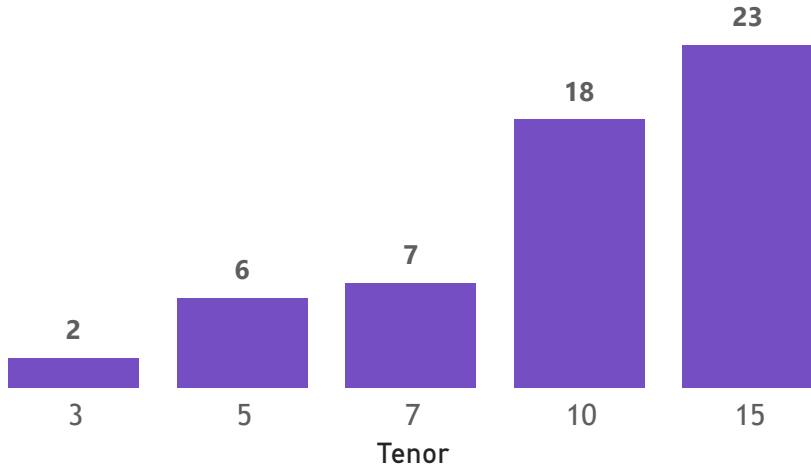


YTD trades
